The U.S. Department of Agriculture, Animal and Plant Health Inspection Service, Wildlife Services Control (WS) program has completed a Decision/Finding of No Significant Impact (FONSI) on an Environmental Assessment (EA) for Bird Damage Management (BDM) at livestock feeding facilities in Kansas.

The EA analyzes potential environmental effects of a proposal to provide operational BDM services when requested by livestock feeding facilities that are experiencing damage by blackbirds, starlings, feral pigeons, and house sparrows. Based on the analyses contained in the assessment, it was concluded that the proposed action will not have a significant impact upon the quality of the human environment.
