GENERAL NOTICE TO CON-TROL NOXIOUS WEEDS

The Kansas Noxious Weed Law K.S.A. 2-1314 et seg requires all persons who own or supervise land in Kansas to control and eradicate all weeds declared noxious by legislative action. The weeds declared noxious are: field bindweed, musk thistle, leafy spurge, hoary cress, quack grass, russian knapweed, kudzu and pignut. Bull thistle and/or multiflow rose is/are a County Option Noxious Weed/ Weeds declared noxious by the Board of County Commissioners of Sherman County. Notice is hereby given pursuant to the Kansas Noxious Weed Law to every person who owns or supervises land in Sherman County that noxious weeds growing or found on such land shall be controlled and eradicated. Control is defined as preventing the production of viable seed and the vegetative spread of the plant.

Failure to observe this notice may result in the County:

1. Serving a legal notice requiring control of the noxious weeds within a minimum of five days. Failure to control the noxious weeds within the time period allowed may

2. filing criminal charges for nor compliance. Conviction for non compliance may result in a fine o \$100 per day of non-compliance with a maximum fine of \$1500.

The public is also hereby notified that it is a violation of the Kansas Noxious Weed Law to barter, sell o give away infested nursery stock o livestock feed unless the feed is fee on the farm where grown or sold to a commercial processor that wil destroy the viability of the noxious weed seed. Custom harvesting machines must be labeled with a label provided by the Kansas Dept of Agriculture and must be free o all weed seed and litter when enter ing the State and when leaving a field infested with noxious weeds Additional information may be ob tained from the Sherman County Noxious Weed Department or by contacting the Kansas Dept. o Agriculture, 109 S.W. 9th, KS 66612.
