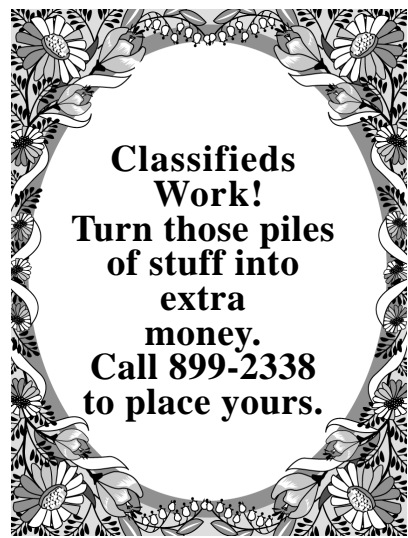

LEASE PURCHASE RESOLUTION

RESOLUTION

BE IT RESOLVED THAT:

The board of education of the above-named school district shall be authorized to enter into a lease purchase agreement to remodel existing high school classrooms for a period of time not to exceed three (3) years in an amount not to exceed eight hundred thousand dollars (\$800,000.00). The lease purchase agreement authorized by this resolution may be adopted, unless a petition in opposition to the same, signed by not less than five percent (5%) of the qualified electors of the school district, is filed with the county election officer of the home county of the school district within thirty (30) days after the last publication of this resolution. In the event a petition is filed, the county election officer shall submit the question of whether adoption of the lease purchase agreement shall be authorized to the electors of the school district at an election called for the purpose or at the next general election or in accordance with the provisions of the Mail Ballot Election Act, as is specified by the board of education of the school district.

This is to certify that the above resolution was duly adopted by the Board of Education of Unified School District 352, Sherman County, Kansas, on the 13th day of March, 2001.

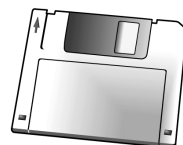
