Man hired to seed acres by airport

killer and seed, it would be a \$9,000 project. He said they can't plant crops, but must go back to natural grass because the Federal Aviation Administration has regulations saying crops would be too tall.

The cost for spraying the acres Knott Just Books or the High Plains reward of up to \$1,000. would be \$1,100 to \$1,200, Pickman said, and the seed mixture would cost \$7,000 and then \$795 to seed.

He said the grass seed mixture would be 40 percent blue grama, 30 percent buffalo grass, 20 percent smooth brome and 10 percent Western wheat grass.

Commissioner Tom Rohr made a motion to approve the bid from Mike Cochran for \$795 and \$5,689 for the seed for a total of \$6,484. The motion carried. Pickman said the area will be seeded by May 10.

Pickman asked Mayor Chuck Lutters to sign a form on behalf of the commission from the Land and Water Conservation Fund.

He said years ago the city received a grant for the area where the Steever Water Park is being built and the grant says that the city guarantees the area will remain a recreation area. No power or telephone lines can go over the project area, he said.

The form is something that is signed every year, he added, and the grant is administered by the Kansas Department of Wildlife and Parks for the National Parks Service.

In a related topic, Commissioner Curtis Hurd asked about the charge for the Goodland swim team to use the pool. Pickman said they would pay \$1

a week and the fee would be the same as those kids who played softball. Hurd asked if and when the city

would advertise the cost for admission to Steever Water Park. Pickman said they would advertise around the first part of May, before the new swimming pool opens.

Billinger asked about the sprinkler system at the new ball field. Pickman said it was done last fall. Ed Wolak, public works director, said there was a little concrete work to be done at the ballfield. Pickman said there are a lot of trees to be planted yet.

The Kansas Corporation Commission issued a ruling Tuesday under which gas and electric companies will be prohibited from turning off customers' service through May 31 for non-payment of
