#### **ORDINANCE NO. 1450**

AN ORDINANCE REGULATING THE STORAGE AND USE OF LIQ-**UEFIED PETROLEUM WITHIN** THE CORPORATE LIMITS OF THE CITY OF GOODLAND, KAN-SAS

BE IT ORDAINED, BY THE GOVERNING BODY OF THE CITY OF GOODLAND, KANSAS.

SECTION 1. Containers allowed for the storage of liquefied petroleum within the corporate limits of the City of Goodland, Kansas, shall be limited to a maximum size of 500 gallons aggregate water capacity. Containers of a size greater than 100 gallons water capacity shall be placed on a metal or concrete stand permanently attached to the ground. Each container used for the storage of liquefied petroleum shall have a label approved by DOT or ICC stating the capacity of the container, a serial number, and be in compliance with NFPA 58. Liquefied petroleum containers supplying trailer houses shall be governed by Section 9-119 of the Code for the City of Goodland. This ordinance shall not apply to liquefied petroleum bulk storage

Prior to approval of the application the Building Inspector or Fire Chief for the City of Goodland shall make a site inspection to approve the location of the storage tank and inspect the appliances that will use liquefied petroleum as a fuel source. The installation of liquefied petroleum burning appliances, piping and all appurtenances shall meet all codes adopted by the Governing Body of the City of Goodland.
