Natural Gas Bill Relief Available To Those Who Qualify

UtiliCorp United Inc. d.b.a. Peoples Natural Gas (Peoples) and Kansas Public Service (KPS) has funds available for a natural gas assistance program due to an order from the Kansas Corporation Commission. The funds result from refunds of Ad Valorem taxes received from natural gas producers.

Now through November 1, 2001 aid is available. Eligible customers may qualify for up to \$325 in relief on their gas bill. You may qualify if you fall within these guidelines:

- You were a residential gas customer of Peoples or KPS in all or part of the 2000-2001 heating season (November through March).
- Your current family income is at or below 300% of the federally defined poverty level. (For example, this would include a family of four with a household income of up to \$52,950.)
- You have not received full LIEAP benefits in respect to the 2000-2001 heating season (November through March).

If you are eligible or think you may be eligible for assistance, please contact the **Salvation Army at 800-336-4547 ext. 402** to fill out an application.
