**ORDINANCE NO. 1463** AN ORDINANCE DEFINING AND **DESIGNATING THE BOUND-ARIES OF THE WARDS OF THE** CITY OF GOODLAND, KANSAS, AND AMENDING AND REPEAL-**ING SECTION 5-201 OF THE** CODE OF THE CITY OF GOODLAND.

**BE IT ORDAINED BY THE GOV-ERNING BODY OF THE CITY OF GOODLAND, KANSAS:** 

SECTION 1.
