now in greater demand WICHITA (AP) — On Sept. 10, in chemistry, operations and technician Sedgwick County Fire Chief Stewart work. Some have hundreds of hours in Segraves was in Alabama taking a training beyond that, giving them the course on nuclear and chemical weap-

ons. One objective was learning to cope with as many as 10,000 victims. Someone asked, "When will we ever

have to deal with 10,000 patients?" The next day, Segraves recalls, the

class had its answer.

In the wake of the Sept. 11 terrorist hijackings and the anthrax attacks that followed, hazardous materials handlers have been in greater demand than ever before.

"Up until that time, terroristic-type stuff was really a new thing," said Lt. Kip Hiebert, a firefighter and member of the Wichita-Sedgwick County hazardous material response team.

On average, the 45-member team receives a dozen calls a day about suspected anthrax - well below the 100plus calls that came in over five days last month, but still more than in anyone's memory.

Team members are firefighters who have taken at least 80 hours of courses

expertise to train other firefighters, medical service and health department officials throughout the Midwest.

They deal with anthrax reports, discarded drums on the roadside, gas odors, gas spills and chemical leaks, among other things.

There is no additional pay or benefits for the duties, but the firefighters say compensation wasn't the reason for joining the team.

"I wanted to protect myself and my people," said Wichita fire Capt. Brian Hoy, who has been with the team for 17 years.
