December 22, 1901: NOT A MISFORTUNE: The following dispatch appearing in a recent issue of the Kansas City World from Osborne, Kans.: “A few days ago John A. Morton, of Osborne, bought a sections of land in Sherman County for \$960 and sold it the day following for \$1,114. Some years ago it was considered almost a misfortune to own land in Sherman County.

December 23, 1901: A \$500 Christmas Present — Last Saturday E. Thorson, the grocer, received a draft for \$500 as a Christmas present from his half brothers and sisters who reside at Seneca, Ill. It was, of course, a very pleasant surprise and testifies to their kindly and fraternal feeling toward their brother. The donators are all quite wealthy people and all reside in the same vicinity. Mr. Thorson and these five half brothers and sisters are all the children of the same mother, although different fathers, and the gift shows the peculiar strength of the family tie.
