painting was erected in east Goodland on June 19.

Sunflowers U.S.A., a group formed to bring the 24- by 32-foot painting to Goodland, started raising money and making plans in 1999, after a Canadian artist said he'd like to include this "Sunflower Capital" of Kansas in his project.

Cameron Cross, a former high school art teacher, said he wanted to do something for the town where he worked in Canada and decided to paint a huge copy of van Gogh's famous sunflower painting. When he started researching the painting, he found van Gogh had a series of seven, and he decided to expand his project.

Cross got an engineer to design the sculpture, which includes the painting mounted on a huge wooden canvas and attached to an 80-foot steel easel. He has erected paintings in Canada, Australia and Goodland, and plans to put the remaining four in Amsterdam, Japan, Argentina and South Africa.

In Goodland, the sculpture faces I-70 and is east of the new section of Cherry Street, which was completed this summer. The painting is part of plans for a new city entrance, including Pioneer Park, which could go in this fall.Organizers say they will hold a dedication ceremony for the sculpture this spring and Cross plans to at-

About two-thirds of Kansas' more than 40,000 full-time employees are part of its civil service system.

This year, salaries and benefits account for more than \$1.87 billion or about 20 percent of the state budget of \$9.2 billion. The general fund, which holds most tax revenues, is supposed to pick up about \$932 million in salary costs, or about 21 percent of the \$4.5 billion appropriated from it.

That makes any proposal to raise salaries expensive — and difficult when the state faces a budget crisis.

"It's not unreasonable in a tight year that you forgo some of the increases you would like to do," Edmonds said. Talk like that bothers Weibel, who is

## First Lady visits Topeka


TOPEKA (AP) — First lady Laura Bush spent her day with the kids and her evening with the grown-ups as she helped celebrate the renovation of a public library.


