Super Bowl 'tasty bets' hard to pay

JEFFERSON CITY, Mo. (AP) - It was easy for Missouri Gov. Bob Holden to make tasty bets on the Super Bowl with his Massachusetts counterpart. But paying up is causing the governor some indigestion.

Holden's wager backing the losing St. Louis Rams included Charlie Gitto's famous toasted ravioli. Then he learned that Acting Massachusetts Gov. Jane Swift has an intolerance to gluten; wheat flour is part of the ravioli recipe.

Told of Swift's condition by The Associated Press, Charlie Gitto Jr. tracked down a recipe for gluten-free flour from Fazio's Italian Bakery in St. Louis.

"The good governor WILL have special toasted ravioli that I'm preparing myself," Gitto declared Tuesday. "Nothing is too much trouble to help my good friend Bob Holden show Governor Swift he's a man of his word."

After untangling some red tape, Swift will have Missouri wine to wash down the pasta. Holden's office learned that the Missouri wine he wagered could not legally be brought into Massachusetts because of state liquor control laws.

But Holden spokesman Jerry Nachtigal said Tuesday that Massachusetts arranged to issue a special permit allowing three bottles of red wine from Missouri Norton grapes to be delivered to Swift. Three wineries from the Show-Me State will each provide a bottle, the spokesman said, although the producers hadn't yet been selected.

"We're trusting the governor has no grape allergies," Nachtigal joked.

However, the Michelob that Holden wagered is made with wheat. There's the gluten glitch again, and St. Louis brewing giant Anheuser-Busch Cos. Inc. isn't inclined to adjust its historic recipes.

Swift had previously promised to give her toasted ravioli to the statehouse press corps in Boston, saying the Patriots' victory was New England's best news in years.

Reporters may be out of luck, however, if Swift decides to keep the gluten-free ravioli.


