ORDINANCE NO. 1470 AN ORDINANCE VACATING A UTILITY EASEMENT IN THE CITY OF GOODLAND, KANSAS. BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GOODLAND, KANSAS.

504. SECTION I The following utility easement is hereby vacated pursuant to K.S.A. 12-504.

A tract of land in the Northeast Quarter (NE 1/4) of Section Eighteen (18) in Township Eight (8) South, Range Thirty-nine (39), West of the Sixth Principal Meridian, in Sherman County, Kansas, described as follows.

Vacate a portion of the utility easement described in Book 96 Page 806 as follows:

Beginning at a point 80 Feet North and 860 Feet West of the Northwest Corner of Lot One (1), Block One (11, Toekles Addition to the City of Goodland, Kansas; thence North 235 Feet; thence West 240 Feet; thence South 235 Feet; thence East 240 Feet, or more or less, to the point of beginning.

SECTION 2. This Ordinance does not release, vacate or otherwise pertain to that particular utility easement which was filed the Register Deeds Office of Sherman County, Kansas, the 4th day of December, 2001, at 3:42 p.m. and recorded in microfilm book 116 at page 471-473.

SECTION 3. That this Ordinance shall take effect and be in force from and after its publication in the official City newspaper as provided by law. PASSED AND ADOPTED this 19th day of February, 2002.
