Fulwider said the Brewster-based company will soon be in direct competition with Southwestern Bell by offerand cable television to Colby and Goodland. Tomlin said Bell's position on the pending bill is not about hostility toward competitors.

"We believe this new law could service. open up the market by setting prices to attract competition and stimulate in-

Bell officials said they see the delivery of broadband as bigger than any one company or constituency.

"It's about a stronger economy and empowering Kansas with tools for the 21st Century," Tomlin said, adding the ing telephone, long distance, Internet bill wouldn't cost the state or customers any money, and it would shift the focus of state regulation from setting prices to the more appropriate role of overseeing consumer protection and

will attract competition and stimulate

in the wireless industry, for example, led to more competitors, lower prices and new services. As a result, cellular phones are everywhere."

For Southwestern Bell to make this type of investment, he said the laws that regulate the delivery of services must be the same for all competitors. Now, cable companies can offer unregulated broadband service but telephone companies are regulated.

"We welcome fair competition," "Letting the marketplace set prices Tomlin said. "If we are all playing by the same rules — the more the merrier – investment," Tomlin said. "New rules whether our competitors use our net-

"In exchange for regulatory reform (as outlined in the bill)," he said, "my company will make a commitment that we will put high-speed service in every community we serve that wants the services and signs up a minimal customer base.'
