# Hospital board views new radiology machines

The Goodland Daily News The Goodland Regional Medical Center board toured the radiology department and asked questions about the hospital's new machines at its regular meeting Monday.

Wendy Fritz, director of diagnostic maging, led a tour to the mammography machine that was installed last summer.

The machine cost \$60,000, Fritz said, and is certified for three years, after which it will need to be recertified

The hospital wanted a home-like feel for the room, she said, to make it more comfortable for women.

Also increasing the comfort for women who need the test, she said, is the fact that the machine is fast. It takes tested, she said, the hips, the forearm is stored in the computer, Fritz said. If

only 15 seconds to take each picture and then immediately releases the breast.

A mammography test requires four pictures, she said, two of each breast, and is normally done on women 40 and over. Fritz said the youngest woman she has done a mammogram for was 20.

Fritz said she would rather not do mammograms on women under 40 and only does them if there are symptoms of breast cancer.

Fritz then led the tour to the bone density scanner installed this winter. It goes hand-in-hand with the mammography machine, she said. Patients who need a mammogram also need a bone scan.

Then the results can be compared, she said, and show if there has been

The test takes 20-30 seconds, she said, and is useful because osteoporosis is preventable and most insurance companies will pay for the test.

The machine replaces a mobile service that came to the hospital once a month. Since having the new machine, Fritz said, the hospital has averaged about two test per day. Mostly women have the test, she said, but five men have been tested in the last month.

Fritz next took the tour to the new x-ray machine. It has tomography capability, she said, which means it can divide the body and take pictures at various levels.

The bed for the machine can be lowered to the floor, making it easier to take x-rays of patients in wheelchairs.

With two x-ray machines, she said, the hospital is better able to handle accidents with multiple victims.
