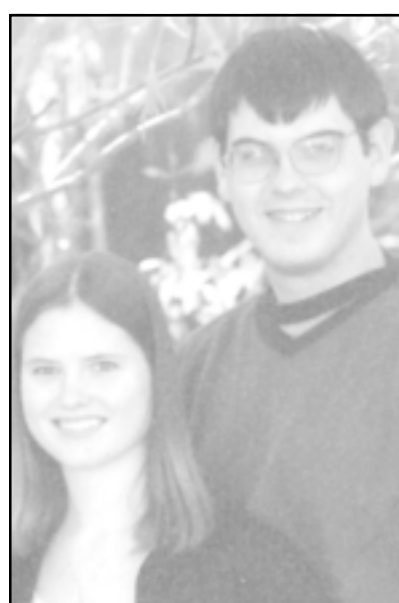

## obituary

### Bud King

V.R. "Bud" Knapp King, 80, a former car dealer, city councilman and freighter in Burlington, died Wednesday, May 8, 2002, at Kit Carson County Memorial Hospital. He had been ill for several years.

He was born Jan. 10, 1922, near Bethune, Colo., to Bertha I. King and Raymond S. Knapp. He graduated from Bethune High School in 1940.

He enlisted in the Air Force in the spring of 1941. While stationed at Sheppard Army Air Base in Wichita Falls, Texas, he met Mildred Morrison. They were married Dec. 21, 1942.

Their first child, Virgil Richard, was born Aug. 25, 1944, while Bud was stationed in Hawaii. He finally got to see him in the fall of 1945.

The couple settled in Burlington, and in 1947, Bud purchased the city dray business and expanded it to haul freight, lumber, cement and coal for Foster Lumber Co.

He later created King Motor Co., a Pontiac, Buick, GMC and Rambler dealership and service center. After retiring, he bought the family farm where he raised cattle, wheat and corn until retiring to travel and spend winters in warmer climates.

He was a charter member of the Burlington Veterans of Foreign Wars and one of the founding members of the First National Bank of Burlington. He was on the planning committee of the Burlington Country Club and served two terms on the city council.

Family was his focus. While raising their own children, Bud and Mildred found time and love for 14 foster children. He enjoyed watching his grandchildren and great-grandchildren grow up.

Through his woodworking talent, he created many keepsakes for his family and friends.

He visited much of the country, traveling with Mildred in their motor home.

He was preceded in death by his parents; a daughter, Phyllis King at the age of 4; three brothers, Les, Leo and Harold King; two sisters, Wilda and Dorothea; and a son-in-law, Craig Mann.

Survivors include his wife; a son, Dick (Jane) King of Craig, Colo.; three daughters, Sue (Doug) Keirnes of Littleton, Colo., Debbie (Barry) Hinkhouse of Burlington, and Julie Mann of Goodland; a sister, Mabel (Howard) Pickerill of Burlington; 15 grandchildren; and seven great-grandchildren.

Services will be at 11 a.m. Monday, May 13, 2002, at the Burlington Christian Church with the Rev. Paul Barker officiating. He will be cremated after the service and a private burial will be held later.

Visitation will be from 6-8 p.m. Sunday at Love Funeral Home in Burlington.

## Group seeks to develop county

"We are all part of Sherman County," Hurd said, "and having such an organization backed by the money from the property tax would be an improvement in funding economic development."

A member of the audience said the group should look to successful cities for ideas, and that one of the main things is that a full time person is needed to handle economic development.

He said an effort would not be easy, quick or cheap to develop

Another suggestion would be to look at cities of comparable size around the area to see what they have done. Phillipsburg was one suggested.

Larry McCants of the First National Bank said he felt the group could learn from the efforts of the 1980s, when a strategic plan was drawn up to set development goals for Sherman County. He said more than 100 people helped develop a vision for the future which was presented to the county commissioners.

He said grants were available then to help and they had the University of Kansas study the demographics of the county, and an expert from Kansas State University came to Goodland to help with the meetings.

Looking at the goals of that group, McCants said the top priority was improving the entrance to the city.

"We've come a long way," he said, "and it is probably time to do it again. The effort would give us a sense of what the community felt was the top priority today."

Randy Topliff, of Overhead Door Co., said he had served on three such economic development committees, and that while all three had been successful, they did not create a lasting group to keep the effort going.

"We must have the money to make something happen," Topliff said. "I am ready to put in \$1,000 from my overhead door business along with the county, city and others. We need to hire a full-time person to do this, and maybe a group where you pay a membership."

Schlyer Goodwin, of Bankwest, said he agreed with Topliff.

"A leader has to have a team," he added. "It takes more than that one person. We need to do what it takes to move the project ahead. Everyone needs to stay active to make it happen."

Larry Harper of Lincare said he thought the plan was good, but before we can sell Sherman County to people elsewhere, first we have to sell Sherman County to the people who live here.

Goodwin said the goal is to have 100 to 150 members in the new organization.

tion.

"Good leadership is key," he said. "and we need to be sure all our meetings are public so we can get the input of the people. The final point is that there can be no personal agendas; we have to put the community interest first."

West asked for volunteers for the steering committee. About 30 names were mentioned. The group then suggested Goodwin as the spokesperson, and he suggested that the steering committee meet with the county commissioners at 8 a.m. Tuesday. He said after getting an idea from the commissioners, they would then probably meet again that week to plan out the organization.

The plan was to present the plan to the full group in three weeks, but an exact date or location wasn't decided.
