Stovall files lawsuit over congressional redistricting

TOPEKA (AP) — Legislators took more than a year to find congressional boundaries they could agree on. The attorney general took three days to prepare a lawsuit calling their plan unconstitutional.

Attorney General Carla Stovall filed a federal lawsuit Wednesday at the request of Junction City officials upset over how the plan would redraw the state's four U.S. House boundaries to put their community and neighboring Fort Riley in different districts.

Legislators approved the proposal on May 16, and Gov. Bill Graves signed their bill into law Friday. Graves said he had reservations about the legislation but signed it because he wanted elections to move forward as planned.

In a statement, Stovall said: "I agreed to file this lawsuit after much careful consideration as to what is in the best interest for the citizens of Kansas to ensure equal representation."

The lawsuit in U.S. District Court in Topeka named Secretary of State Ron Thornburgh as the defendant. It asks the court to issue an injunction preventing Thornburgh's office from conduct-

ing elections based on the map. It also asks the court to move back the Aug. 6 primary elections if necessary

"We are going to ask the court to let us proceed under existing law," said Thornburgh. "Setting back the date of the primary would be a dangerous thing to do."

Stovall's office offered a new map with the lawsuit that would keep Junction City in the 2nd District with Fort tween the 2nd and 3rd Districts. Riley. The map was not considered by lawmakers.

Oleen was pleased with the attorney general's decision and defended Stovall's proposal as legitimate.

"The map she submitted is every bit as valid as any other plan," said Oleen. "If we're comparing procedure, the map the governor signed was a liquor bill; it was not put together in a redistricting committee; it did not have a public hearing."

Legislators approved their plan after the House and Senate passed radically different proposals and negotiators for the two chambers deadlocked. The House then stripped a liquor bill

of its contents, dumped in its redistrictaccepted it.

Under the plan lawmakers approved, Junction City would move to the 1st District with western Kansas, while Fort Riley would remain in the 2nd, with Topeka and most of northeast Kansas. That plan — and alternatives offered by Stovall and Junction City officials --- would split Lawrence be-


