Fire on French express train kills 12 passengers

By the Associated Press INTERNATIONAL NANCY, France — A fire broke out

in a sleeper car on overnight express train today, filling the car with smoke and killing 12 passengers, officials said. Five Americans were among the dead, the U.S. Embassy said.

At least eight others were injured, none seriously.

The train with 150 passengers was passing through the eastern French city of Nancy when the fire broke out three hours after departing from Paris on route to the southern Germany city of Munich, the French rail authority SNCF said.

The cause was an electrical shortcircuit in the sleeping car where the blaze originated, according to regional French authorities.

Most if not all victims — six men, five women and one child — died of smoke inhalation, authorities said. Their identities were not immediately known, although the German Foreign Ministry in Berlin said four of dead appeared to be German.

Richard Lankford, spokesman for the U.S. Embassy in Paris, said that five Americans died in the fire, according to information received from French authorities.
