

Williams wants Hinrich to shoot

KANSAS CITY, Mo. (AP) — Now that Kansas opponents no longer have Drew Gooden to worry about, it figures that Kirk Hinrich and Nick Collison will draw a lot more attention.

Hinrich, whom coach Roy Williams calls the best guard in the country, seemed to always be drawing a crowd during the Jayhawks' 81-57 victory against Holy Cross Tuesday night in the Preseason NIT.

He wound up with 13 points on 3-of-5 shooting, while Collison carried the load with 20 points and 8 rebounds.

The No. 2 Jayhawks (1-0) will host North Carolina-Greensboro tonight in the tournament's second round.

"I'd like to see (Hinrich) take more (shots) if they're good shots, but I thought they really were concerned about Kirk Hinrich, and that's what he's going to have to face — and Nick's going to have to face," Williams said Thursday.

"Last year Drew took more shots and

scored more, so he was the focus of the other team's defense. They really worked him." Williams said.

"I would like Kirk to shoot more and shoot the same percentage, and I do think we've got a couple of things that can help him get the shots. At the same time, we're just trying to give him the advantage, and if they come running at him, then somebody else has the advantage and Kirk's the kind of player that will give it up.

"I think if you look back, I would have wanted Kirk to shoot more in probably 75-95 percent of the games he's played," Williams said.

It's something Jim Hinrich, Kirk's dad and high school coach, always wanted as well.

"I talked to his dad one time and his dad said he felt probably the same way in high school," Williams said. "He wanted him to shoot more in high school. But we're not out there playing, and for the most part Kirk makes really good decisions."

Another big difference from last year is the absence of guard Jeff Boschee, the Big 12's career leader in 3-point shooting.

So far, nobody has stepped forward to completely fill that void. But Williams is not about to lose any sleep over that.

"I don't get concerned and look at that stat sheet and say, 'Well, we only shot five 3-pointers,' because I'm interested in winning," Williams said.

"If it helps you to win to shoot more 3-point shots then I want us to do it, and if it doesn't help us to win and we don't need to do it, then I really don't care. I've always said if I had my druthers, I'd have my best 3-point shooters shooting 3-point shots and other than that nothing but dunks.

"But that doesn't happen. I'm not that concerned. I know everyone else seems to be, but we were all right the other night and we shot five 3-point shots. I saw some teams shot 25, 27 and lost."
