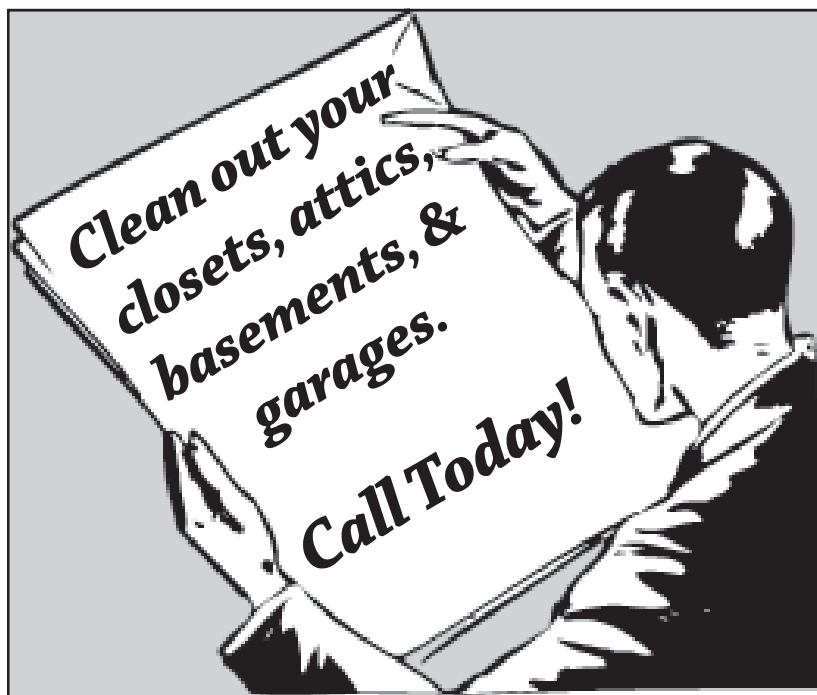

CHARTER RESOLUTION NO. 18

A Charter Resolution Exempting Sherman County, Kansas, From the Provisions of K.S.A. 19-264, and Providing Substitute Provisions on the Same Subject.

Be it Resolved by the Board of County Commissioners of Sherman County, Kansas:

Section 1. That Sherman County, Kansas, under authority of K.S.A. 19-101a, et seq., and any amendments thereto (County Home Rule), hereby elects to exempt itself from the provisions of K.S.A. 19-264. K.S.A. 19-264 as amended, is part of an enactment commonly known as Petty Cash Funds, which enactment does not apply uniformly to all counties.

Section 2. The following is hereby substituted for the provisions of K.S.A. 19-264, as amended: The provisions of K.S.A. 19-264 and

amendments thereto, shall not prevent the establishment and authorization of a Petty cash fund in any county office based solely on the population of Sherman County.

Section 3. This Charter Resolution shall be published once each week for two consecutive weeks in the official county newspaper.

Section 4. This Charter Resolution shall take effect 61 days after final publication unless a sufficient petition for a referendum is filed, requiring a referendum to be held on the resolution as provided in Article 12, Section 5 of the Constitution of the State of Kansas, in which case this Charter Resolution shall become effective upon approval by a majority of the electors voting thereon.

Passed by the Governing Body, not less than two-thirds of the members elected voting in favor thereof, this 10th day of December 2002.
