6402 County Road 16 (west on old U.S. 24)

Reynaldo's Mexican restaurant opened at Cherry and 17th and Taco John's opened on K-27. Curt's Corner Garage expanded and opened a new paint and body shop. In November, the two closed gas stations were bought by Mike and Mark Olderbak, owners of Kabredlo's, of Nebraska, and are to reopen in the new year. Roof work is being done on the one at 8th and Caldwell, and environmental tests are being done at 17th and Caldwell.

Finley's Motor, the Buffalo Inn and Cowboy Loop changed owners. With the openings and closings, the overall business level probably came out even for the year.

Contributing to the economic problems were the problems were the effects of • The drought, which cut the spring wheat harvest. The dry weather forced the city to impose watering restrictions and the county to institute a burn ban. The watering restrictions began in July and the burn ban at the end of June. Both were lifted at the end of September when the county received some much-needed rain. The dry weather all but erased the fall harvest, which was about half of what had been expected. Many dryland fields were never harvested.

The county received enough moisture to help get the winter wheat crop started, but not enough to say the drought is over. Weather forecasts indicate there may be a chance for more normal moisture in the new year, but the High Plains remained dry.

S & T Telephone of Brewster announced it would be build ing new, state-of-the-art fiber optic systems in both Goodland and Colby. Work began in the spring to lay fiber optic cable throughout the two cities, with completion expected sometime this year. The telephone co-operative built offices in both cities and moved into the one in Goodland at the end of December. S&T announced the first phase of customer sign up to begin on Monday for selected parts of the system. The company will provide both local and long distance phone service as well as Internet service lines.

Goodland Regional Medical committee to organize under the Center announced in May it was undertaking a \$1 million upgrade of the hospital's computer system to improve record keeping and to simplify the clinical, laboratory and billing processes. Administrator Jay Jolly, who was hired at the beginning of the year, said the cost was high, but that the hospital would save about \$300,000 by going to the new computer system. The hospital sought approval for tax credits to raise money for the project. The board asked the county for money and got \$200,000 from the health services sales tax fund. The computer system is being installed and phase 1 of the switch is underway. As part of the upgrade, the hospital is working with S & T to provide fiber optic connections for telephone and Internet service. The hospital announced in the fall that it would show a loss of about \$400,000 for the year, and announced a series of cuts and rate increases to help offset some of the red ink. The 2003 budget announced in December shows the hospital losing more than \$200,000 in the next year, but the cash flow

Bad: In August, there were two fatal accidents in the same day. The morning of Aug. 22, Diane Tompkins, 43, drove off the road at the curve on K-27 south of Goodland and died when she was thrown from her car. That afternoon, Mary Alice Garcia, 35, of Kanorado was killed when her car crashed into a semitractor rig about three miles southeast of Kanorado.

Gunplay: In July, two men robbed the Sinclair station out by I-70 of over \$200. A 19-year-old clerk, Casey D. Brock, gave police a detailed description of the robber and a companion, and Colorado officers nailed them just across the state line. She said she was quitting her job, saying one robbery was more than enough.

Violent: A wind storm in August caused damage in Ruleton and Kanorado, ripping up roofs and a grain dryer at an elevator.

Buzz: The West Nile virus, which infects bird, horses and people, was a big story in August. The virus was found in Sherman County in September. It had spread rapidly through the surrounding states and was in more than half of the counties in Kansas.

Bronze: In September, the new Ad Astra statue destined to be placed on the Capitol dome made its first stop in Goodland on a tour of Kansas on its journey to Topeka. It took longer than expected to get the statue on the dome because the holes for the bolts had to be redrilled. The statue looked a lot bigger on the truck in Goodland than to does on the top of the statehouse.

Amystery: While working on the parking lot of the new People's State Bank, workmen came across an old handgun buried beneath the concrete. Sheriff Doug Whitson said he was not sure if there was a crime connected with the gun, but thought there might have been a murder about the time the old concrete was poured in 1959.

On the lam: In late October, Goodland Daily News Sports Editor Doug Stephens left the office to pick up film at Wal-Mart and disappeared. He left behind a wife, Amanda, and two young children.

To the ground: Dec. 1, the Stuckey's restaurant near Brewster burned to the ground. State fire officials were investigating.
