ORDINANCE NO. 1496
AN ORDINANCE DEDICATING PROPERTY AS PUBLIC RIGHT-OF-WAY WITHIN THE CITY OF GOODLAND, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GOODLAND, KANSAS:

SECTION 1. Pursuant to K.S.A. 14-423 the City declares as open the following described street: A tract of land situated in Tract 2 of the Eastridge Subdivision to the City of Goodland, Sherman County, Kansas all in the Northeast Quarter of Section Twenty (20), Township Eight (8) South, Range Thirty-Nine (39) West of the Sixth (6) Principal Meridian in Sherman County, Kansas, and being more particularly described as follows:

Commencing at the Northeast Corner of said Tract 2 of the Eastridge Subdivision, plat recorded in Plat Book 3 at Page 5 and 6 and filed in Folder 27 of the Sherman County, Kansas records; Thence South along the easterly line of said Tract 2 a distance of Fifty (50) feet; Thence West along a line parallel with and Fifty (50) feet southerly of the northerly line of said Tract 2 a distance of 315.36 feet to the westerly line of said Tract 2 and the easterly line of a tract of land described in Book 112 Microfilm at Page 113 of the Sherman County, Kansas records; Thence North along the easterly line of said tract and along the westerly line of said Tract 2 a distance of Fifty (50) feet; Thence East along the northerly line of said Tract 2 a distance of 315.36 feet to the point of beginning.

SECTION 2. Said property is hereby dedicated as Public Right-of-Way.

SECTION 3. After the passage and publication of this ordinance the same shall be filed with the Register of Deeds and the County Clerk of Sherman County, Kansas.

SECTION 4. This ordinance shall take effect and be in full force and effect from and after publication in the official City Newspaper.

ORDINANCE NO. 1495
AN ORDINANCE VACATING A PORTION OF A STREET RIGHT-OF-WAY IN THE CITY OF GOODLAND, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GOODLAND, KANSAS:

SECTION 1. The following street rights-of-way are hereby vacated pursuant to K.S.A. 14-423.

A right-of-way in the Northeast Quarter (NE 1/4) of Section Twenty (20) in Township Eight (8) South, Range Thirty-Nine (39), West of the Sixth Principal Meridian in Sherman County, Kansas, described as follows:

All of the Eustis Avenue Street right-of-way in the Campus Addition to the City of Goodland, Sherman County, Kansas, from the northerly right-of-way of Thirteenth (13th) Street to the northerly line of said Campus Addition, plat recorded in Plat Book 3 at Page 9 and filed in Folder 27 of the Sherman County, Kansas records.

Also, a right-of-way in the Northeast Quarter (NE 1/4) of Section Twenty (20) in Township Eight (8) South, Range Thirty-Nine (39), West of the Sixth Principal Meridian, in Sherman County, Kansas, described as follows:

All of the Eleventh (11th) Street right-of-way in the East Ridge Subdivision to the City of Goodland, Sherman County, Kansas, from the easterly line of said East Ridge Subdivision to the easterly line of a tract of land described in Book 63 of Deeds at Page 697 of the Sherman County, Kansas records, East Ridge Subdivision plat recorded in Plat Book 3 at Pages 5 and 6 and filed in Folder 27 of the Sherman County, Kansas records.

SECTION 2. The City of Goodland hereby reserves unto itself a utility easement and drainage easement in the above described tracts.

SECTION 3. That this Ordinance shall take effect and be in force from and after its publication in the official City Newspaper as provided by law.

ORDINANCE NO. 1494
AN ORDINANCE AMENDING AND REPEALING CHAPTER 4, SECTION 4-304(4) OF THE ELECTRIC CODE OF THE CITY OF GOODLAND, KANSAS.

BE IT ORDAINED, BY THE GOVERNING BODY OF THE CITY OF GOODLAND, KANSAS.
SECTION 1. Section 4-304 (4) is amended to read as follows:

300.3 Conductors. All wiring in and on new and old buildings for commercial, industrial and multifamily uses shall be installed in approved EMT and ENT conduit or shall be of an approved metal-clad cable or armored cable.

Exception No. 1. Modulators wired with Type NM cable may be used as commercial offices only when all of the following criteria are met.

- (a) The modular is not wired with aluminum wiring;
- (b) The modular is not attached to any other building, carport, breezeway, awning or other appurtenance;
- (c) The modular has a separate electric service which would include an exterior disconnect; and
- (d) The structure is not required to be fire-rated according to the building code for the City of Goodland, Kansas.

SECTION 2. Chapter 4, Section 4-304(4) of the Code of the City of Goodland is hereby repealed.

SECTION 3. This ordinance shall take effect and be in full force and effect from and after publication in the official city newspaper.

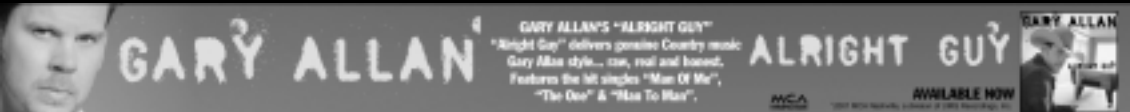

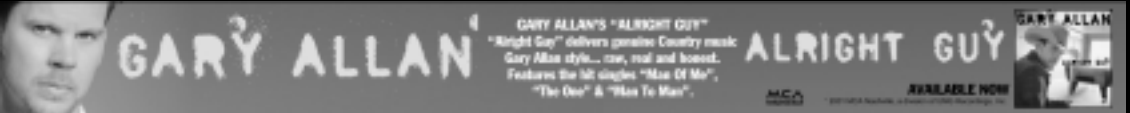
