

Senior is scholarship semifinalist

Alyssa Mason, a Goodland High School senior, has been selected as a semifinalist in the 2002-03 Coca-Cola Scholars Program. From over 100,000 applicants nationwide, she will be one of 2,000 seniors vying for \$1.8 million in college scholarships.

Students are selected as semifinalists based on excellence, leadership and achievement demonstrated in school and community activities. As a semifinalist, she has been asked to submit information to be reviewed this month by a committee of 27 educators from high schools and universities throughout the country.

If selected as one of the 252 finalists, Mason will travel to Atlanta on Thursday-Sunday, April 24-27, to attend the Coca-Cola Scholars Weekend. During the visit, she will attend a final interview which will determine whether she will be a national or a regional scholar.

The 52 national scholars each receive a \$20,000 renewable scholarship.

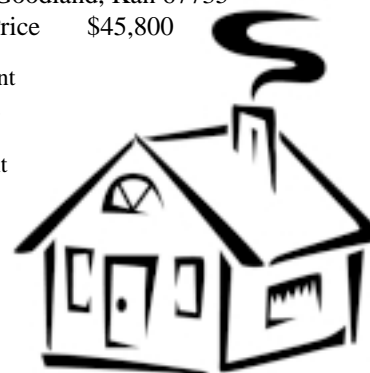
