April 8, 1903: Salary Too Small - County Superintendent John R. Reed was sitting in his office chair recently working as industriously as though his salary was as large as any of the officers of the county. The qualifications of his office requires that he shall hold a state certificate, be a graduate of an accredited college or normal school and must have taught at least 18 months. And yet, for all of these requirements, the state allows him the magnificent sum of \$450 annually for his services. He is limited to working 150 days and is paid \$3 per day, aggregating, if he works the whole number.

Besides a multiplicity of duties, 1,200 to 1,500 gets \$700, and so on he is required to visit the various schools of the county. To do this, he has to own a horse and buggy or hire \$600.
