

Artists needed for May

The Carnegie Arts Center is looking for participants for its May gallery show, "TableScapes," featuring tables set by local organizations and individuals.

The center plans a reception to open the show on Sunday, May 4. Throughout the month, Arts Center Director Tina Goodwin said, visitors will be asked to vote for their favorite table.

At the end of the show, she said, the organization with the table with the most votes will win \$100.

Members of an organization can design a table, Goodwin said, or an individual can design a table on behalf of an organization.

Participants will be asked to set and decorate a table that will be on display at the arts center through Saturday, May 31, and provide all the materials.

Designers are encouraged to come up with a theme for their table, which can be as traditional or creative as they like. The gallery has room for six four-person tables and three 6-8 person tables. Entries will be taken on a first come, first served basis until Friday, April 25. There is no fee.

Goodwin said the success of the center's Holiday Home Tour has shown that entertaining and home design is a definite art form.

"We wanted to find a forum to display these talents," she said, "and give our local home design experts a showcase to display their creative skills."


