ORDINANCE NO. 1503

AN ORDINANCE ESTABLISHING FEES FOR THE COLLECTION OF WASTE MATERIAL PURSUANT TO ORDINANCE NO. 1502 OF THE CODE OF THE CITY OF GOODLAND, KANSAS.

BE IT ORDAINED, BY THE GOVERNING BODY OF THE CITY OF GOODLAND, KANSAS.

SECTION 1. Solid Waste and Related Collection fees. In accordance with the definitions and provisions established by Ordinance No. 1502 of the City of Goodland, Kansas, the following fees are hereby established for the collection of waste materials.

SECTION 2. Residential Refuse Collection Service Fees.

a. All residential refuse customers within the City of Goodland shall be charged a base rate for the collection of refuse in the amount of \$13.25 per month. The base rate includes one collection of refuse, and the tipping fee for such collection, each week.

b. All rural residential refuse customers shall be charged a base rate for the collection of refuse in the amount of \$15.25 per month. The base rate includes one collection of refuse, and the tipping fee for such collection, each week.

SECTION 3. Commercial Refuse Collection Service Fees.

a. All commercial refuse customers within the City of Goodland shall be charged a base rate for the collection of refuse in the amount of \$12.00 per month. The base rate includes one container with one collection of refuse each week. In addition there is a tipping fee of \$2.10 per collection per container. Any additional containers shall be charged the same

fee.
b. Additional Collections. Any commercial refuse customer may request additional collections of refuse. Each additional collection shall be charged a fee of \$10.00 per trip, per collection site and an additional fee of \$2.10 tipping fee for each collection per container.

SECTION 4. Yard Waste Collection Fee.

a. Any residential customer contracting yard waste collection with the city and/or its contractor shall be charged a fee as follows:

1. Three-cubic yard dumpster: \$12.00 per month or any part thereof for each dumpster.
2. Ninety-gallon poly-cart: \$4.00 per month or any part thereof for each poly-cart.

a. Any commercial customer contracting yard waste collection with the City and/or its contractor shall be charged a fee as follows:

1. Three-cubic yard dumpster: \$12.00 per month or any part thereof for each dumpster.

SECTION 5. Metal debris and heavy and bulky item collection fee. Any residential customer may request by special arrangement the collection of certain metal debris, and/or heavy bulky item debris. Such collection shall be in accordance with the City approved rules, regulations and fees as established by the contractor of the City.

SECTION 6. This ordinance shall take effect and be in full force and effect from and after July 1, 2003, and after publication in the official city newspaper.

PASSED AND APPROVED this 25th day of June, 2003 by the Governing Body of the City of Goodland, Kansas.

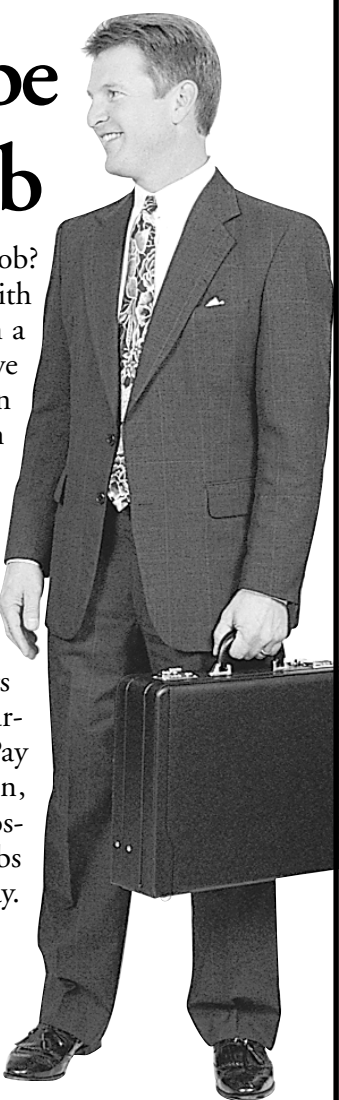
