ORDINANCE NO. 1504

AN ORDINANCE PERTAINING TO THE PAYMENT OF FEES FOR COLLECITON OF WASTE MATERIAL AS DEFINED IN CHAPTER 7, ARTICLE 1 OF THE CODE OF THE CITY OF GOODLAND, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF CITY OF GOODLAND, KANSAS:

SECTION 1. All waste collection bills due the City and/or its contractor shall be payable monthly and all such bills shall be paid on or before the fifteenth (15th) day of the month in which the bill is received. Unless payment is made as herein called for, service may be discontinued until such delinquent customer shall have paid all of the arrearage to the City and/or its contractor. The City has the right, in addition to discontinuing waste

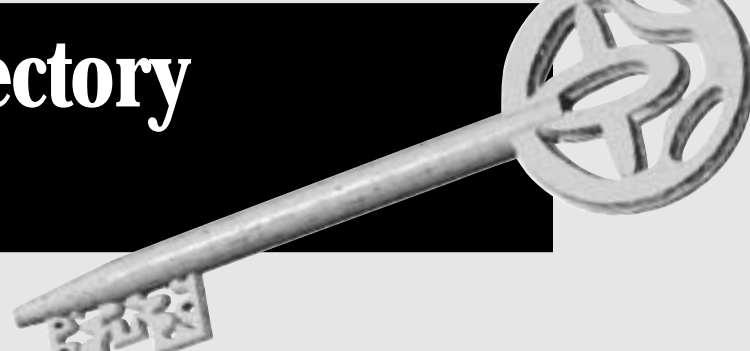
