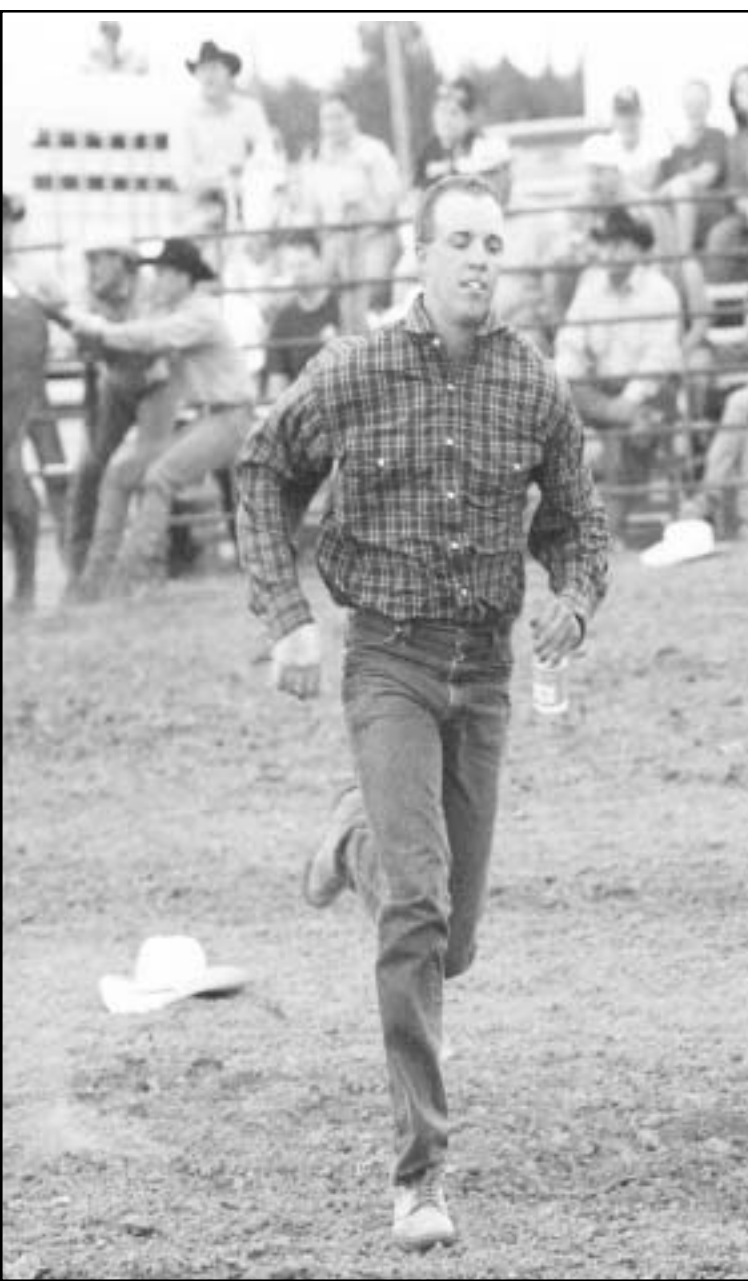


Roping and rustling at 3rd Annual Ranch Rodeo
