## Slice of Life money buys new tub for hospital patients

The Goodland Star-News Patients at Goodland Regional Medical Center can now bathe in style in the hospital's new \$15,600 bathing system, purchased with money raised at the Slice of Life auction and golf tournament.

Patient Care Director Debbie Hickman told the hospital's board Monday that the first patient to use the tub enjoyed it so much they could hardly talk her into getting out.

For some patients, Hickman said, baths will be safer than showers. But that is not the only benefit. The reservoir can be filled while a staff member goes to get the patient, she said, and a temperature gauge shows whether the water is comfortable.

When the patient gets in, Hickman said, the tub can then be filled in 70 seconds from the reservoir. With this feature and an ultraviolet light to kill bacteria and the whirlpool, she said, it's not a tub; it's a bathing system.

It is the same model as the tub the Good Samaritan Center has had for five years, Hickman said, but this one is an upgrade.

Thanks to money raised by the Slice for Life golf tournament, Goodland Regional Medical Center patients will have a safe alternative to a shower with a new tub. Doug Jones (right) of Apollo demonstrated the tub last week for Eloise Fuentes and Martha Alfaro.

"It has been a morale-booster for the staff," she said. "They haven't been able to give baths."

The reservoir makes the bathing system efficient, Hickman said, allowing up to four baths per hour.

The Northwest Kansas Area Medical Foundation gave the hospital \$20,000 from the Slice of Life for the bathing system and two more large-size wheelchairs, to replace damaged carpet with tile and for signs to direct patients to the new central registration area. Director of Human Services Dale Schields, who is executive director of the foundation, said the money raised at this year's event was earmarked for the tub.

"It was absurd not to have one," he said. In other business, the board:

· Welcomed a new member, Darin Neufeld, a Goodland engineer.

 Approved a training site agreement with Southeast Community College of Beatrice, Neb. Nurses in the college's web-based radiology program who live in this area will train at Goodland Regional Medical Center. The hospital will not have to pay the students, Schields said, and there is no expense to the hospital whatsoever. Administrator Jay Jolly said the college provides liability insurance for the students.
