Darin Miller, SBC director of external affairs from Garden City, said he had no problem competing for the county's phone service, but that he wants to be sure the quote from the competition is comparing apples to apples.

Commissioner Kevin Rasure complained about a lack of communication with the company. He said that they do not see anyone from the firm and find it hard to contact anyone.

"I keep telling my bosses that the main frustration in northwest Kansas is a lack of personal contact," Miller said. "I have been telling them we should have a person in Goodland and Colby to handle questions and answer the phones. I think they are beginning to listen a little, and I will tell them again."

"I know that SBC wants to get into all aspects of the communication business including the video," he said. "They are working on an agreement with Echo Star to allow customers to order Dish Network through SBC, and it would be billed on the monthly statement.

"I will do what I can to keep your business and ask that when you are looking at the service, please contact us to give us a fair chance.'

Rasure thanked Miller for coming, but said it seemed like the company only shows up when it looks like they are going to lose the customer. Miller said he would try to see that the county has more up-to-date information when there are changes in rates and new services being offered.

Workers see small increase

The Goodland Star-News City workers will see a 1 percent

increase in their pay beginning in January based on a plan adopted by the City Commission on Monday, with some eligible for merit raises of up to 4 percent. City Manager Ron Pickman said

all full-time employees will receive the 1 percent cost of living increase except the city manager, who is under contract. The pay plan includes a provision

for merit raises based on the employees annual performance evaluation. The merit raise can be up to 4 Employees hired before January

2000 will receive their merit raise on Jan. 1. Those hired after Jan. 2000 will receive any merit raise on their anniversary date.

Employees who have reached the maximum of their pay level will only receive the cost of living increase, Pickman said.

The commissioner unanimously approved the pay plan.

City Commissioner Chuck Lutters said he though the schools may need to have the sewer rates adjusted under the new ordinance. He said it might be good to charge the district based on the water usage of December, January and February in a similar manner to residential charges.

"I know they are using less during these months because all the sports activity is inside," Lutters said. "I think it is something we need to look at, but we won't really know until the new rates go into ef-

Commissioner Dean Blume said he did not want to make changes in the new sewer rates unless there was

a clear need. "How many of these are we going to hear about?" Blume asked.

No action was taken on the sewer rates, but Pickman said he would be willing to look at the situation. Mayor Rick Billinger reported

that the city commissioners had attended the annual dinner sponsored by Aquila, the city's gas utility. Company representatives said they expect the gas rates to go up this winter, but not as high as expected.

The next city commission meeting will be 5 p.m. on Monday, Dec. 1, in the commission room on the second floor of the City Administration Building at 204 W. 11th.




