Small pox outbreak was not as bad as reported

Sherman County Historical Society **December 1, 1903**: Small Pox Condition Not So Bad as Reported – The appearance in Goodland of a few cases of varioloid, a mild form of small pox, is a case of where the bark of the dog is worse than the

Several persons unknowingly exposed to the disease came down as would be expected, but as soon as the doctors tacked the name of small pox to the infection, people at once became frightened, and a pimple on a man's nose, or a nose otherwise red, was cause for a stampede in a safe direction.

General precaution is now being exercised, and infected houses have been isolated by quarantine. Reports of the contagion have run rampant east and west along the Rock Island until an exaggerated impression is current about the small pox in Goodland.

Last week this paper reported 15 cases of the disease, but upon more careful investigation it was found that the number was fewer than that. At the present time there are only six houses in town where small pox exists.

Dr. Farrow resigned as health officer last week, and at a session of the county commissioners Monday, Dr. Smith was appointed, who has the matter of public health now in hand, and it is expected that the small pox scare here will soon be a thing of the past.

December 2, 1903: Dewey Case Set For Dec. 7 — The trial of Chauncey Dewey, W.J. McBride and Clyde Wilson, charged with the murder of the Berry family, is set to be heard Dec. 7 before the Cheyenne county district court at St. Francis.

It is believed improbable that the case will come to trial at that time. For several months, it is said, the attorneys for the Deweys have been canvassing the county to find if it is possible to secure a jury.
