Irrigation scheduling helps yields

Irrigation scheduling helps farmers maximize yields and reduce water and energy use.

Many may be familiar with KanSched, an irrigation scheduling tool from Kansas State University that determines when and how much irrigation water to apply. specialists at Kansas State University, is tailored to Kansas crops and growing conditions.

Irrigation scheduling using evapotranspiration values is much like checkbook accounting. In this case, soil water, rather than money, is the valued commodity. The debit is crop water use, while credits are rainfall and irrigation.


