# State health board seeks nominations

The board is asking for nominations for:

- The Consumer Council, which

will provide guidance to the board on health care access, quality, affordability, sustainability and health promotion. Members will include people across Kansas who represent various consumer interests.

• The Provider Council, representing health care professional interests, which will provide guidance on issues pertinent to health care providers. It will give input on health policy that affects providers and patients, make recommendations on outreach to the provider and the medical communities and encourage provider participation in public programs.

• The Purchaser Council will represent health and health care purchaser interests. Members will be responsible for providing advice on health policy that impacts employers, insurers and other purchasers of health care service.

## Ellen June Henderson

Ellen June (Manteuffel) Henderson, 77, St. Francis, retired Cheyenne County register of deeds, died Wednesday, Jan. 3, 2007, at the Cheyenne County Hospital.

She was born June 21, 1929, on her grandparents' farm southwest of St. Francis, the daughter of Walter and Viola Ellen (Evins) Manteuffel. She attended St. Francis Community High School, graduating in 1947.

While in high school, she sang in the a cappella choir and played in the school band. Her favorite hobby was playing piano.

On May 16, 1947, she married Virgil Henderson in Wray, Colo. They had six children.

Caring for her family was her No. 1 priority, and she often worked more than one job. She ran the Top

Lunch for Jim Jones, waited tables and washed dishes at the Saintry Cafe and the Bay Cafe and cooked at the Bon Ton Cafe. She often said that she worked in every St. Francis restaurant.

Mrs. Henderson also worked for Caldwell's and Jim Jones Phillips 66, handled numerous bookkeeping jobs and delivered *The Denver Post*. In 1977, while working at Keeler's Building Supply, she decided to run for register of deeds. She was sworn into office following that election and in 1997 retired after 20 years.

She joined the Lawn Ridge Church when she was 12 and was a member of the St. Francis First Baptist Church at the time of her death. She played for services and served

as clerk at the church and was active in the Baptist Women.

Mrs. Henderson was a member of the Veterans of Foreign Wars Auxiliary and served as treasurer many years. She joined the Rising Star Rebekah Lodge in 1972 and held many offices, serving as Nobel Grand in 1979. She joined the Ladies Auxiliary Patriarch Militant and Ladies Encampment Auxiliary. She was a past secretary for the Department Association Ladies Auxiliary Patriarch Militant.

Preceding her in death were her parents; a nephew, Deloy Manteuffel; and a son-in-law, Thomas "Woody" Terry.

Survivors include three sons, Darrel (Beverly) Henderson of Amarillo, Texas, Steven (Bette)

Henderson of Chickasha, Okla., and Brent Henderson of St. Francis; three daughters, Virginia Terry and Brenda (Gary) Drennen of Goodland, and Becky Henderson of Wellington; a daughter-in-law, Amelia Henderson; a brother, Walter "Buddy" Manteuffel Jr. and wife Winnie of Hays; 18 grandchildren; and 24 great-grandchildren.
