David Hans Schilling, 94, Westmoreland, father of Dale (Darlene) Schilling of Goodland, died Wednesday, April 25, 2007, at the Westy Community Care Home in Westmoreland.

He was born Nov. 30, 1912, near Havensville, the son of Carsten and Mary (Bateman) Schilling. He attended schools in Havensville, where he played sports and graduated in 1934.
