take," Hill said. "If they have been here 20 years and it happens once, banks said. are they gone?'

"Has our policy worked that we have now?" Daniels asked.

"It depends on who you talk to," Mason said. "I think it has worked to answer the needs we as a city have, and has given us the flexibility to handle things that have happened."

Hill said there are always going to be some cases where there is an emergency, and if an employee is asked to come to work and says he has been drinking, there may have to be a judgment call.

Volk said she liked a chart that gives an estimated alcohol level after one drink based on the person's size, weight and gender.

Mason said the chart says a man of 170 pounds would test at .02 if he had a beer and was tested immediately. He said he would not recommend the city adopt the chart because there are so many variables the chart cannot cover.

Fairbanks asked if the city has a 'three strikes and you're out" provision?

"No, we have been going on each situation," Volk said.

"We have been going on a caseby-case situation," Mason said, "and we are figuring it would be two violations before the person would be terminated.'

He said finding a cup containing liquor in a city vehicle would be an automatic termination. There are some precedents the city has used in the past, he said.

can change it or be willing to defend it."

"I don't mind defending it," Fair-

Dechant said he did not feel the policy needed to be changed, but asked if it applied to everybody.

Volk said the basic policy is for everyone, but the government requires random testing for those with a commercial drivers license or in 'safety-sensitive" jobs.

"We have a reasonable suspicion policy for everyone," Hill added.

The manager said he and some of the department supervisors went to Garden City for a course on how to determine if someone is intoxicated. "Do we need a 'two strikes and your are out' in this policy?" Dechant asked.

"Need, I am not sure," Mason said. "We have done that in the past on a case-by-case basis.'

Garcia said he felt there should be more structure in the policy to leave less room for misinterpretation.

"I think there has to be some structure," he said. "I know we have good employees who do good things for the community, but it only takes one time for something to happen and get the city into a liability situation.'

"I think it is structured enough now," Mason said, "so the employees know what will happen, and gives the employer flexibility to handle each situation.'

"I agree," Daniels said. "I don't think it is that bad. I think it has been working and I think it is good enough to handle the situations."

Simon said the important thing is "The current policy has worked," that you have to document everything.




