**ORDINANCE NO. 1577** 

AN ORDINANCE AUTHORIZ- A RESOLUTION FINDING agents, lienholders, occupants ING WITHDRAWAL OF PAR-TICIPATION BY THE CITY OF GOODLAND, KANSAS IN THE OPERATION OF THE MUNICI-PAL ENERGY AGENCY OF NEBRASKA AND TO PRE-SCRIBE THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

**BE IT ORDAINED BY THE** MAYOR AND CITY COMMIS-SION OF THE CITY OF GOODLAND, KANSAS:

Section 1. The City Commission hereby finds and declares it to be in the best interest of the City of Goodland, Kansas to withdraw its participation in the Municipal Energy Agency of Nebraska, an agency formed pursuant to the Municipal Cooperative Financing Act contained in the Nebraska Revised Statutes 18-2401 et seq., and relieve the City of Goodland's designated Director and Alternate Director from the MEAN Board of Directors. At the present time, the Agency is comprised of the following municipalities:

Nebraska: Alliance, Arnold, Bayard, Beaver City, Benkelman, Blue Hill, Bridgeport, Broken Bow, Burwell, Callaway, Chappell, Crete, Curtis, Fairbury, Falls City, Gering, Grant, Imperial Public PowerDistrict, Kimball, Lyman, Mitchell, Morrill, Nebraska City, Oxford, Pender, Red Cloud, Shickley, Sidney, Stuart, Wet Point, Wood River;

Colorado: Aspen, Fleming, Fort Morgan, Glenwood Springs, Gunnison, Haxtun, Julesburg, Lyons, Yuma;

Kansas: Goodland;

Wyoming: Basin, Torrington

It is anticipated that there may be other municipalities that may become participants pursuant to the provisions of the Municipal Cooperative Financing Act.

The general description of the business in which the Agency engages, and the location and method of operation of the proposed plants and systems of the Agency are:

To generate and supply electrical energy and engage in the Montana Avenue, Goodland, ownership and operation of Dower projects as defined in the  $\,$  ous and directs that such struc-Municipal Cooperative Financing Act, within and without the State of Nebraska, and exercise all other powers granted by law relating to the above activities. The principal place of business shall be Lincoln, Nebraska.

Section 2. It is hereby ordered and directed that the City of Goodland, Kansas, acting through its Mayor and City Clerk, withdraw as a participating municipality in Municipal Energy Agency of Nebraska, an organization which has been created pursuant to the Municipal Cooperative Financing Act contained in the Nebraska Revised Statutes 18-2401 et seq., and do all things necessary to terminate the City of Goodland's representation on the MEAN Board of Directors. This would include the submission of an application to the Municipal Energy Agency of Nebraska expressing this City's desire to withdraw.

Section 3. This Ordinance shall be in full force and take effect after its passage, approval, and publication as provided by law.
