b. The Franchisee shall assume the cost of publication of this franchise when such publication is required by law. A bill for publication costs shall be presented to the Franchisee by the City Clerk.

SECTION 18 FORCE MA-JEURE It shall not be a breach or default under this Ordinance if either party fails to perform its obligations hereunder due to force majeure. Force majeure shall include, but not be limited to, the following: 1) physical events such as acts of God, landslides, lightning, earthquakes, fires, freezing, storms, floods, washouts, explosions, breakage or accident or necessity of repairs to machinery. equipment or distribution or

Each party shall make reasonable efforts to avoid force majeure and to resolve such event as promptly as reasonably possible once it occurs in order to resume performance of its obligations hereunder; provided, however, that this provisettle any labor strike.

SECTION 19 SEVERABIL-ITY. If any section, paragraph, sentence, clause, or phrase of this ordinance is for any reason held invalid by the decision of any court or regulatory body of competent jurisdiction, such decision shall not affect the validity of the remaining portions. 
