**ORDINANCE NO. 1585** 

AN ORDINANCE RELATED TO PROVIDE REGULATIONS FOR PARKING AND OPERA-TION OF VEHICLES UPON STREETS DURING TRAFFIC **EMERGENCIES AND UPON** STREETS DESIGNATED AS **EMERGENCY ROUTES AND AMENDING SECTION 16-215** (c) OF THE CODE OF THE CITY OF GOODLAND, KANSAS.

**BE IT ORDAINED BY THE GOVERNING BODY OF** THE CITY OF GOODLAND, Rachel E. Gentry was fined \$120 KANSAS:

> Section 1. The following provisions of Section 16-215 (c) of the Code of the City of Goodland, Kansas, are hereby amended to read as follows:

(c) Declaration of traffic emergency during winter weather. Whenever snow has accumulated or there is a possibility that snow will accumulate to such a depth that snow removal operation will be required, the mayor or in the absence of the mayor, the city manager or the director of public works, may declare a traffic emergency and until such traffic emergency is terminated,

it shall be unlawful:

1. To operate a motor vehicle on a city street designated as an emergency route during a traffic emergency caused by snow and ice without first having equipped such vehicle with tire chains, except that motor vehicles with four-wheel drive need not be equipped with tire chains.

2. To park a vehicle on any street designated an emergency route in subsection (f) of this

Section 2. This ordinance shall be effective upon its passage and publication once in the official city newspaper.
