nexpected tragedies reported

Life on the High Plains over a century ago was filled with unexpected tragedies, especially when horses were involved. The Goodland Republic reported that Sherman County had its share of unfortunate accidents in the fall of 1901. And the young and elderly suffered alike.

KILLED IN RUNAWAY Joseph Walker, Aged Mail Carrier, Thrown from Roadcart and Kicked to Death by Horse

Joseph Walker, carrier of the mail from Goodland to Charlotte, was thrown from his roadcart and killed Saturday afternoon when about six miles northeast of town. No one saw the accident but as near as can be learned it occurred shortly after two o'clock and he was dead when found about half an hour later by his nephew, James Walker, who was coming to Goodland.

Walker lived near the Charlotte post office and had carried mails for several years, making the trip from Charlotte to Goodland and return Tuesday, Thursday and Saturday of each week. He left Goodland at 1:30 Saturday for the return trip, and it is thought that in going down a long but steep hill the horse gained considerable speed and suddenly turned across the deep cut road, throwing the old man under the

animal's feet. There were two bad wounds from the horse's feet on his head and face.

Joseph Walker was a Scotsman and was born in Belfast, Ireland, 69 years ago. He came to America in 1882, and to Sherman County in 1888. He leaves a son, Joseph, his wife having died before coming to this country. William Walker, Sr., of this county is his brother.

Services were conducted by Rev. Good, pastor of the Methodist church.

(The Charlotte post office was operated by Mrs. Jennie Nedrow until 1908 in the Voltaire township on the Beaver northeast of Goodland. In the next article Muldrow was located in the Llanos township, also in northeast Sherman County.)

DEATH CAME INSTANTLY Sad Ending of George Dillinger Who Was Kicked by a Horse



shock to his family.

George Dillinger was kicked by a horse December 11 at 4:30 p.m. and died instantly. He was the second son of D.W. Dillinger, county commissioner of the First District. The three boys were in the barn unharnessing a team when a horse in the barn stepped on a chicken. George went and got the horse off the chicken, which, it is supposed, flew against the heels of the colt in the same stall, scaring the animal which kicked and struck the boy in the stomach. He fell to the floor. He got up and started for the door but had gone only a few feet when he started to fall but was caught by his father who was carrying feed to the

barn. He swooned and was carried to the house.

The oldest son hurried to Brewster and telegraphed to Dr. Gulick at Goodland, who arrived at Brewster on the 8:30 train and was immediately driven to the Dillinger home. Sadly the young boy had passed away before the doctor arrived.

The funeral was held from the Muldrow school house Friday, the services being conducted by Rev. Shackelford, of Brewster. The day was a bitter cold one, but the funeral was largely attended.

George Blair Dillinger was born December 17, 1885, near Harvard, Clay County, Neb. His parents moved to Sherman County, Kans., in 1886, where the rest of his short life was spent. He died at the age of 15 years, 11 months and 24 days old. He was converted and joined the Christian church in the year 1895. He leaves his father, mother, two brothers, and two sisters to mourn his death.
