Board votes to advertise

The Sherman County Convention and Visitors Bureau decided to advertise in the annual Wildlife and Parks Hunting Regulations book but not to hire a photographer or give him a free room for the state Division of Travel and Tourism.

The board voted to spend \$610 for a full-color ad in the guide, which will print 277,000 copies. That's about 2/10ths of a cent per copy, said Bill Stoick, board secretary and owner of the Super 8 Motel.

A photographer hired by the tourism division will take pictures Monday at the Goodland Travel Information Center, said Director Donna Price, and may take pictures of the giant Van Gogh replica in Goodland. Price asked the board if they would be willing to provide a room.

'He's getting paid to do his job," said board member Lincoln Wilson of the Howard Johnson Hotel, "and he may or may not stay beyond taking advantage of our hospitality."

He should either pay for his own room, Wilson said, or the state should pay for it.

Price said the photographer had offered to come back to shoot pictures for the bureau, charging \$500 for a four-hour shoot or \$250 for

The state hired Steve Crecelius when he comes to take pictures of Wonder Works Studios in the Denver area to take pictures for its "Ready-Made Adventures" guide. The adventures are on the department's web site, in the Kansas Getaway Guide and will be featured in magazine advertising, Price said.

> When the photographer comes Monday, she said, the state will own those pictures. If he comes a second time, she said, the bureau would own those pictures.

"If they're doing an I-70 project in the getaway guide," Wilson asked, "how could they not include the travel information center, the only one in the area, or the Van Gogh replica, the only one in the country?"

Price said the photographer would come Monday for the state whether a room is provided or not, but the second trip would depend on the visitors bureau choosing to pay.

The pictures could be used for the bureau's brochures, the Goodland and Sherman County guide, the northwest Kansas guide, the bureau's web site and advertising, she said.

The first two firemen carried the fire hose to attack and put out the fire, and the second pair were in search of the victim.

Fire Chief Brian James had told the rescue team the victim was thought to be in the front of the house, and told the attack team the fire was in the kitchen area in the back of the house.

The two rescue team members kept a hold of each other as they used their hands to search for the victim in the smoke filled house, and in a few minutes reported they had tound the victim and were heading back with him.

A third volunteer fireman held the door open and fed the fire hose in to the attack team, who reported by radio they had found the fire and had put it out.

The two team retraced their path and exited the house.

normal exercise as the lead man on the rescue team was Commissioner Dave Daniels and the lead man on the fire hose was Commissioner Josh Dechant. Daniels is a selfemployed rental housing manager and Dechant is the credit manager at Frontier Ad. Both have been on the city commission for more than four years.
