Striping delayed on old U.S. 24

ntbetz@nwkansas.com Flooding in Nebraska has delayed the striping of old U.S. 24 across Sherman County, but the company hopes to be here next week to do the painting, commissioners were told Tuesday.

Curt Way, public works manager, said Casey Clausen of Straight Line of Grand Island, Neb., said his company is running behind because of the flooding in Nebraska, but should be here in the next week or two.

Straight Line was awarded the striping contract back in April with an estimated cost of \$19,000 for both the yellow "skip" line, nopassing lines and the white edge

Way said the state transportation people came out and helped mark the no-passing zones.

Citizens asked the county to paint the stripes last fall after the road had been resurfaced last summer. Commissioners said they liked the idea if the job did not cost too much and the lines would last three to five years.

Clausen said in April there are a lot of variables as to how long the paint will last, but the biggest problems are winter weather and snow plowing. He said he would expect the job to last from one to three years depending on the traffic
