# The Sherman County Conservation District will conduct a sign up June 23 through July 30 for both Non-Point and State Water Resources Cost Share Programs.

Some of the State Water Resources Cost Share Program practices eligible for cost share include Contour Buffer Strips, Critical Area Planting, Diversions, Fencing, Grassed Waterways, Pipelines, Terraces and Livestock Wells and Tanks. Windbreaks have been added this year! Practices will be cost shared at 70% of average cost with a \$5,000 landowner limit.

The Non Point Source Funds can be used for FAIL-ING on site waste water systems and plugging abandoned wells. LEPG will have to evaluate and rank the applications and there will be a \$50 fee upfront for these
