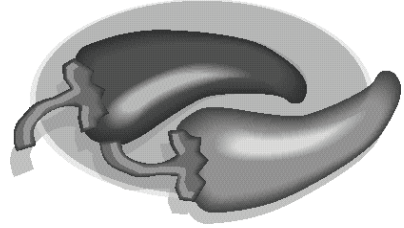
**Saturday, September 27th from 10 a.m. to 3 p.m.**



Entry fee of \$50 per team. Contest will be limited to the first 20 paid entries received before September 17. Checks are to be made payable to Frontier Ag, Inc.

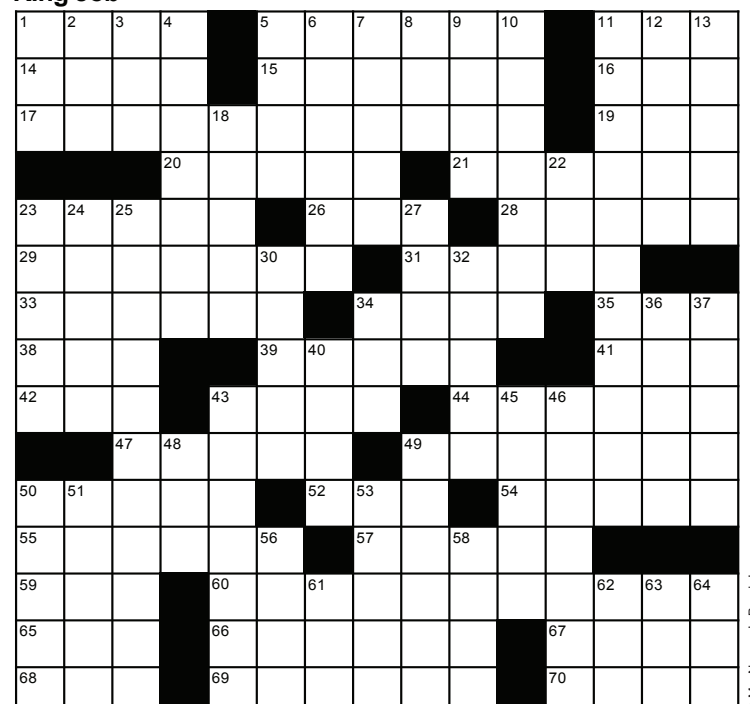
Contestants will prepare their favorite recipe of RED CHILI for judging by a local panel of "experts". The chili

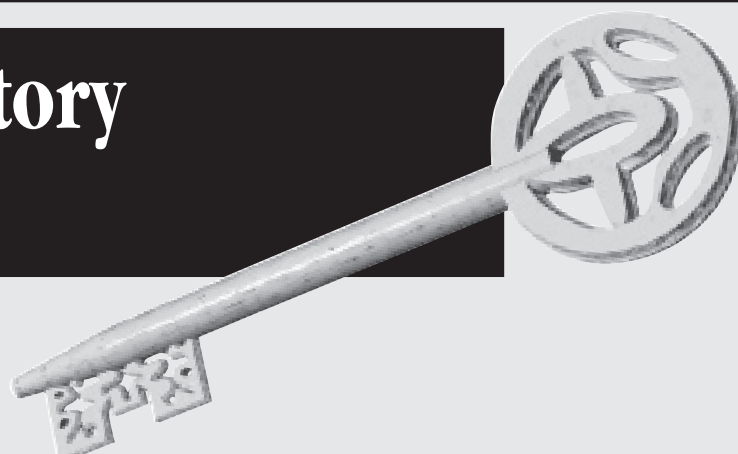
