Tim and Amy Isham moved to Goodland in 2005 from Bailey, Colo., and purchased the Leonard building at 921 Main Ave. Tim is a talented carpenter by trade and has his wood shop in the north half of the building and The Vault Creamery soda shop is in the south half.

The soda shop is old fashioned, created with the feel of an early 1900's ice cream parlor. They serve hard ice cream in different flavors depending on the week, soft-serve ice cream, sundaes, shakes, malts and sodas. Every soda is made by hand and no, they don't stir it with their finger! They use antique soda taps, which do not dispense syrup so you have a choice of 30 soda syrup flavors to choose from. They can make ice cream sodas, which are very popular! M&M's and peanuts, etc. can be added to the shakes, malts and ice cream sodas.

They mix the shakes and malts on an old style malt mixer and build them to order. The Vault Creamery offers sandwiches and

as the weather turns colder, they will have soups on hand to warm the soul.

Thomas and Kate Leonard were real estate agents and had founded the city of Itasca. When the county seat was moved to Goodland, the Leonard's purchased the first two lots, situated on the northeast corner of 10th and Main.

Leonard moved a two-story wood frame hotel from Itasca and placed it on the south lot. He then built a brick office building on the north lot. It was constructed very similar to the hotel with two stories, plate glass windows with two halves for two businesses. There was a fire in the hotel on Aug. 14, 1902 that destroyed the hotel and the brick building to the north as well as other buildings. There was no vault in the brick building but only a small safe. The safe did not survive but the contents did and since the Leonard's were abstractors and had titles and other important documents, they decided to build a fireproof vault

in the new building. The building has been home to many businesses since then. To mention a few, it has been a grocery, newspaper, furniture store and post office (1905-1935).

Tim and Amy are the fifth owners of the building since 1889. The Leonard's sold their abstracting business to Jesse Teeters and Teeters Abstract is still in business in Goodland today with Annette Fairbanks at the helm.

Tim, Amy and their staff would like to extend a sincere invitation to anyone who loves ice cream to come in and sit for a spell, enjoy an old-fashioned ice cream soda and visit. The Vault Creamery is located at 921 Main Street in downtown Goodland. Their phone number is (785) 890-7001.
