## Stadium decorated for game

slcorcoran@nwkansas.com It may have looked like vandalism and shenanigans going on around Goodland High School Wednesday night, but Superintendent Shelly Angelos kept a watchful eye as a group of cheerleaders, football moms and other family members and friends of Cowboys players and coaches drew designs and wrote messages with sidewalk chalk and trash bags.

Some said they heard at a meeting of senior parents the cheerleaders wanted help with decorating for homecoming, while others said it was the football moms who instigated it, but all were eager to make sure the Oberlin Red Devils know exactly whose territory they're in tonight.

Pictures drawn in chalk on sidewalks on the north and south side of the stadium depict a Devil with an ax in its head and a Pink Devil, and messages in chalk include 'Victory," "Devil Down," "Stab the Devils" and "Stomp Over the Devils."

Black trash bags weaved into sections of the chain-link fence spell out "Cowboys" on the north side of the stadium and "Cowboy Territory" on the south side where the Oberlin fans will be sitting. Football mom Dana Murray, mother of sophomore David Murray, worked with cheerleaders on the trash bag art.

Penny Sheldon, mother of senior Kade Sheldon, Tammy Freeman, mother of freshman Mikail Freeman, and Darla Mosbarger, mother of senior Jace Mosbarger, worked on the chalk art. Superintendent Angelos, a football mom herself, mother of senior quarterback Travis Angelos, said she was supervising but was caught with chalk in her hands.

## County budget cuts property tax by 3 percent

ntbetz@nwkansas.com The public hearing on the Sherman County budget for next year will be at 8:30 a.m. on Tuesday, and published figures show a drop of about 3 percent in the property tax level from this year's level.

County Clerk Janet Rumpel said the county assessed valuation increased this year by \$251,351, or about 3.9 percent to \$65,967,695. She said state assessed values for S&T Communications and ON-ROK, a natural gas processing company in Mesquite, TX., had dropped by \$200,000 from last year, but when she took it all out the county was about \$10,000 higher in assessed valuation than last year.

She said that S&T has not put anything new in place and that is why the valuation dropped. She said the state exempted assessment on new equipment last year, but that companies are paying on what had been in place before the law was repealed. She said the amount of valuation for this would continue to drop over the next few years.

Commissioner Mitch Tiede asked how the budget review session had gone last week when Mark Bauer, auditor from VonFeldt, Bauer and VonFeldt of Larned, was at the courthouse to meet with the com-

Rumpel said it went well, and that the Road and Bridge budget had to be adjusted as the estimated expenditures were too high compared to the expected income.

Commissioner Chuck Thomas said the rural fire board was a bit worried about the fire budget being so low, and wondered if they would Rumpel said that was effected by

the change in valuation. Commissioner Kevin Rasure said there was \$250,000 in the special machinery fund for next year, and that he felt that did not need to increase by transferring any more

Thomas said that was one of the things they talked to Bauer about,

and that Bauer seemed to feel that was about the right level for the budget.

"I feel the special equipment fund is adequately funded," Rasure said.

Rumpel said Bauer said if the county doesn't put more money into the special equipment fund the other money can be used for other expenses.

Thomas said that Bauer said it was right to keep it about 15 to 20 percent, and that it has stayed pretty consistent over the past years.

Tiede asked if it would cover what Curt Way, public works manager, has planned.

Rasure asked if the other two commissioners agreed that the \$250,000 amount was reasonable.

"I think it is reasonable," Tiede said.

Rumpel said the anticipated property tax levy for next year is 53.620mills, but that will change slightly with the \$200,000 drop in valuation she received last week.

The property tax levy for this year was 55.294 mills, and the budget for next year would drop that by 1.7 mills or about 3 percent.

The published budget comparison shows the county was frugal in their spending this year as the budget was for \$9,644,886, but estimated spending will be \$7,716,682.

The anticipated spending for next year is \$9,473,970 or a drop of about \$171,000 (1.8 percent).

Rumpel said the budget includes the carry over from each fund, and gives the departments authority to spend up to the budget amount, but that each department tries to keep their spending below the budget limits.
