Have you voted?

The day has finally arrived when people across the country and in Sherman County will decide who wins the election.

The voting poll today for all Sherman County will be from 7 a.m. to 7 p.m. at the Veterans of Foreign Wars at 824 Main, and County Clerk Janet Rumpel said voting machines will be available for any who may need special help.

More than one-fourth of the registered voters in Sherman County had cast their ballots early for the general election Rumpel said. Early voting ended at noon, on Monday.

"We have been swamped," Rumpel said. "We've had 747 walk-in votes, 9 provision ballots and 269 mail-out votes.'

Rumpel said Sherman County has about 5,570 registered voters, and the more than 1,025 who votedearly or requested ballots are about 28 percent of the total of registered voters.

The local contest is in County Commissioner District 2 where Republican Cynthia Strnad is facing incumbent Democrat Mitch

Mock election today on at-large voting

nt.betz@nwkansas.com Sherman County citizens can vote on

the issue of at-large voting of county commissioners in a mock election today at the Goodland Activity Center.

Trevor Linton, chairman of the Shine Committee, said the county commissioners asked the committee to hold public forums on the at-large commissioner issue after a bill to allow voters an opportunity to vote on the issue failed to pass the legislature in Topeka.

He said the mock election will be held from 7 a.m. to 7 p.m. to mirror the hours of the general election at the Veterans of Foreign Wars on the other end of the block.

He said the ballot for the mock election will

simply ask if the citizens of Sherman county to express their opinion on the issue. should have the opportunity to vote on county commissioners at-large.

'We hope people will vote in the General Election and then take a minute to come to the activity center to vote in the mock election.

"We feel the people ought to vote on the On Sherman County Government Alliance issue," he said, "but we have to get it through the hoops in Topeka."

Linton said the committee had been asked by the Sherman County commissioners to hold more than one public forum on the issue. They held a public forum at the Northwest Kansas District Free Fair in August.

He said the committee was looking for another time to do a public forum, but felt with the harvest and school events the mock election would be a good way to get the citizens

"The members of the committee are not taking sides on the issue," he said, "but we are hoping to get as many voters as possible to let the commissioners know what the opinion is throughout the county."

Linton said following the public forum at the fair in August the committee had set up a ballot box to give people a chance to record their opinion.

He said the committee was a bit disappointed in the response getting a total of 87 people to record their vote in that week.

"That is only 2.4 percent of the registered voters (3,570)," he said. "Of those 58 said YES (67 percent) and 21 were NO (24 percent). We had eight who did not sign and those were not officially counted (7 were YES and

1 NO) he said.

Linton said the committee hopes to get a larger percentage of the citizens to come to the GAC to vote. He said unlike the ballots at the fair the people will not be asked to sign the ballot, but will be asked to sign in to let the committee know who voted and make sure people don't vote more than once.

"We really hope more people come to the GAC to let us know what they think about the issue of voting at-large for county commissioners," Linton said. "If a majority want the chance to vote it will have to go back to the legislature in Topeka in January. If the people vote against the issue we expect the commissioners to follow the wishes of the
