Assault, drug charges filed

nt.betz@nwkansas.com Charges of aggravated assault and possession of drug paraphernalia have been filed against a 27 year old Goodland man after an incident Monday morning near the welding building at the Northwest Kansas Technical College.

Joschua Moreno, 27 of Goodland is being held at the Sherman County Bastille after he allegedly threatened Richard Sandoval, 36 of Goodland by displaying a gun during a confrontation about 10:25 a.m. on Monday.

Police Chief Ray Smee said Moreno was sitting in his car and arguing with Sandoval who was standing outside, and that Moreno allegedly had a gun laying on his lap.

Smee said Moreno left the college campus before the police arrived, but he was seen leaving his house at 525 W. 16th and was stopped by officer Doug Whitson and arrested and taken to the Sherman County Bastille. Whitson was assisted by a Sherman County Sheriff's deputy and a Kansas state trooper.

Monday afternoon a search warrant was obtained and Moreno's tobacco, but it is not a complete ban house was searched for the weapon and drugs. Officer Jim Gillespie the primary and secondary schools conducted the search and found a Colt Police Positive .22 cal revolver

and several items of drug paraphernalia at the home. Assisting with the search was Sherman County investigator Burton Pianalto and Doug Murphy of the Quad County Drug Task Force.

Smee said Moreno is being held on charges of aggravated assault, possession of a firearm by a felon and possession of drug paraphernalia.

Moreno was advised in Sherman County District Court on Wednesday and bond was set at \$25,000. A preliminary hearing was tentatively set for Friday, Nov. 21.

Chief Smee said he thought they could charge Moreno with having a weapon on a school campus, but when they researched the Kansas law the prohibition of guns applies to unified school districts in the state.

"I was surprised to find the college was not covered under the state law, and so was County Attorney Bonnie Selby," Smee said. "We thought we had another charge, but a college campus does not fit within the state law.

"The college can prohibit guns from their buildings, and even ban from school property as defined for in the state.




