Colby principal fired for 'acts of moral turpitude'

to fire the high school principal after a special, closed-door meeting Thursday morning, putting the activities director in charge of the school.

The board had announced a special meeting at 7 a.m. Thursday on Tuesday, with a closed discussion of "nonelected personnel" as the only item on the agenda.

After about an hour of discussion, said Superintendent Terrel Harrison, the board voted to accept the resignation of a clerical worker. Kylie Cersovsky. It then adopted that Robbins is entitled to a hearing engaged in unprofessional con-

The Colby School Board agreed the contract of principal Rocky within 15 days. It says Harrison had Robbins.

Harrison said Larry Gabel, the high school activities director and assistant principal, would be the acting principal, effective Thursday. He'll probably get some help with his other duties, she added, but it hasn't been decided who might step up to fill the activities job.
