Money, toys collected for needy 'tots'

slcorcoran@nwkansas.com Their motto is "Children -Priority No. 1," and the Goodland Kiwanis Club is proving it, gathering donations of toys and money amounting to more than \$2,000 per year to give toys to needy children.

Fred Studer started collecting for Toys for Tots with members of the Northwest Kansas Bike Show many years ago, said Brad Schields, lieutenant governor for Division 12 Kiwanis, and joined Kiwanis and asked the club for help four years ago. Kiwanis has been collecting and distributing toys through Genesis each year since, Schields said, with children receiving toys as Christmas gifts.

Kiwanis started the American flag project specifically to raise money for Toys for Tots, he said, and does a drive each year, getting donations from businesses and people in the area. People and businesses can pay the club \$30 a year, he said, to put up an American flag five times a year. There were costs to buy the flags, he said, but next year and from then on, the money will buy toys.

The bike club does a toy run at the Christmas parade each year, he said, and helps collect toys and donations. Kiwanis buys toys locally with the monetary donations, he said, and gives out \$2,000 to \$3,000 worth of toys each year.

There was a good turnout for the collection Saturday at Wal-Mart and the parade, Schields said, but collection will continue until it's time to distribute the toys.

"Kiwanis' motto is Children — Priority No. 1," he said.

Schields said he puts about 15,000 miles a year on his car serving as lieutenant governor, as he watches over the seven clubs in the division. It's a two-year commitment, he said of the post.

But it's worth it, he said, as of the 96 clubs in Kansas, the most money is raised between Goodland and Hays. Hays is the biggest club in the state, he said, and Goodland is the fastest growing with 57 members, having doubled its membership in one year.



Visitors bureau approves budget

slcorcoran@nwkansas.com The Sherman County Convention and Visitors Bureau approved a \$141,000 2009 budget at its meeting last Tuesday.

The budget projects \$114,000 of for insurance. guest tax collected at hotels, motels and bed and breakfasts in the county next year, compared to \$108,000 projected for this year. \$78,327 had been collected through September.

Next year's budget includes \$14,000 of carried over funds and \$13,000 of reimbursements from the Northwest Kansas Travel Couna billboard.
