

Cowboys start year with home game

The Cowboys were busy over the holiday break, and several former team members came out to practice to work with the team to get them ready to return to action at Max Jones Fieldhouse Friday against the Lakin Broncs.

Cowboys Coach Don Smith said he had several former team members come to the practices and felt the holiday practices were valuable for the team.

He said some of the former Cowboys will be practicing with the team the first few days of this week as they do not have to return to college until later in the month.

“We are looking forward to the game on Friday,” he said, “and think we match up well both in size and experience. We would like to get a win to get our confidence up.”

He said Lakin has a new coach, and feels the Cowboys have a good chance to win.

Smith said it will be a tough week with the game on Friday and then without much time to prepare the Cowboys will be at Scott City on

Monday for the second game of the month.

He said when originally planned the game with Scott City was to be in December, but both schools changed their holiday schedule and the game would have fallen while school was out. Neither school wanted to play a game in the holiday break and efforts to find a suitable date ran into problems. Smith said when the Scott City people were willing to play on Monday he accepted as a compromise to get the game played.

Smith said another change to the schedule will be a “C” team game with Greeley County on Thursday. He said the team will travel to Tribune to play that game.

The Cowgirls will play Lakin at 5:30 p.m. on Friday and the Cowboys game will follow about 7 p.m.

Monday the games at Scott City will be at the same times with the Cowgirls going first followed by the Cowboys.
