# Sales tax won't solve school problems

Gov. Mark Parkinson's call to raise the state sales tax by one cent could be a broad way to solve the immediate state budget problems, but he is asking for it to be a temporary increase for three years and that will not solve the school problems in Goodland.

Getting a Republican controlled legislature to consider a tax increase will be tough enough, and most of the leaders are already saying they do not want to raise taxes in an election year.

A poll conducted by a Wichita television station shows public support for a tax increase to stop further cuts in state services, and public support for increasing the cigarette tax by 70 cents. The poll shows public support for banning smoking from public places statewide.

Raising taxes is always a hot button issue in the legislature, and the current budget problems will make it an interesting session to watch as the Republican leadership tries to find a way to balance the budget and keep the citizens from revolting if the budget cutting knife goes too deep.

For the Goodland School District the actions in Topeka will not solve the school building issue, and with the negative decision on Monday the board is back to square one.

After more than three years of public input, having an architect examine the buildings and recommendations from Superintendent Shelly Angelos about which school to close the board remains divided and unable to reach a consensus decision.

At a special meeting in December it appeared a consensus had been reached with four board members indicating support for the recommendation to close North Elementary as the first step in consolidating the classes into three buildings.

That option was tied on a 3-3 vote on Monday, but with Board Member Gary Slough's abstention the vote was tipped to 3-4 and the motion was defeated.

Closing any school is an emotional decision and we understand the reluctance of the board members who are pulled in many different directions on what ought to be done.

The bottom line is the school district cannot afford to operate all the present school buildings, and keeping them open will leave little choice but to cut staff and programs at all the schools.

Even if the state legislature is able to find a consensus to raise the sales tax that will not trickle down enough to save the Goodland School District.

Whatever the final decision making the changes in the buildings and staff will take time, and every delay makes that more difficult.

We felt the recommendation made by Angelos was well thought out, and would be the best for the students in the schools. It was disappointing to see the school board fail to come to terms with this issue, and we hope they find a workable solution soon.

The devastation caused by the earthquake in Haiti draws at the heart strings, and our prayers go out to the people who were hurt in the quake and the many thousands trying to rescue people and bring relief.

This is the second time two Presidents Clinton and Bush have come together to lead an international relief effort. The first time was for the tsunami in Thailand when Clinton and the elder Bush joined forces. This time it is Clinton and the younger Bush who are answering the call. – *Tom Betz*

Last Week at the Statehouse

Last Thursday I received information from a survey conducted by KWCH-TV Wichita. A total of 56 percent responded the state sales tax should be increased in order to prevent further cuts. A total of 71 percent said too many organizations were exempt from sales taxes, 56 percent supported an increase in cigarette taxes and 65 percent supported banning smoking in public places in Kansas.

#### **Earned Income Tax Credit**

You may qualify for Earned Income Tax Credits. The Earned Income Tax Credit is a refundable federal income tax credit for low to moderate-income working individuals and families. Congress originally approved the tax credit legislation in 1975 in part to offset the burden of social security taxes and to provide an incentive to work. When the tax credit exceeds the amount of taxes owed, it results in a tax refund to those who claim and qualify for the credit.

To qualify, taxpayers must meet certain requirements and file a tax return, even if they did not earn enough money to be obligated to file a tax return. The tax credit has no effect on certain welfare benefits. In most cases, tax questions. My office address is Room 274-W credit payments will not be used to determine eligibility for Medicaid, Supplemental Security Income, food stamps, low-income housing or most Temporary Assistance for Needy Families payments. The federal adjusted gross income limits for qualifying for the credit for tax year 2008 (which are adjusted annually for inflation) are intervention and treatment. I am hopeful we as follows:

· For married filing jointly with more than one qualifying child, \$41,646

• For single with more than one qualifying child, \$38,646

· For married filing jointly with one qualifying child, \$36,995

• For single with one qualifying child, \$33,995

· For married filing jointly with no qualifying children, \$15,880

• For single with no qualifying children, \$12,880

"Earned income" basically means salary income. A claimant cannot file "married filing separately" and get the tax credit. A claimant cannot have investment income in excess of \$2,950.00 and get the tax credit. A claimant must be between the ages of 25 and 65 and cannot be claimed as a dependent by anyone to qualify for the tax credit.

Detailed info on this credit is available on the IRS website, www.irs.gov The Kansas tax credit is 17 percent of the federal earned income tax credit.
